This is to bring to your kind attention that **The Bharat Scouts and Guides (BSG)** has been officially recognized as a **Co-Curricular Activity** in CBSE-affiliated schools, as per CBSE Circular No. ACAD-64/2022 dated 07 June 2022, and the subsequent revised circular No. Acad-115/2022 dated 28 September 2022. The National Headquarters of BSG has also released Circular No. 198/2022 dated 13.10.2022 in this regard (copy enclosed).

In Himachal Pradesh, The Bharat Scouts and Guides is fully recognized and functions under the Department of Education, Government of Himachal Pradesh. The Worthy State Chief Commissioner of BSG is the Director of Higher Education, Himachal Pradesh. The organization is operating with full administrative approval and legitimacy.

You are kindly requested to initiate the formation of a BSG Unit in your school, and complete the official registration process through the respective District Association or State Headquarters. Enclosed are documents including the unit registration form, guidelines on how to start a unit, and the official structure and benefits of Scouting and Guiding.

The Bharat Scouts and Guides is the only recognized and authorized organization affiliated internationally with **WOSM (World Organization of the Scout Movement)** and **WAGGGS (World Association of Girl Guides and Girl Scouts)**, and nationally with the Government of India (<https://yas.gov.in/youth/promotion-scouting-guiding>) and Government of Himachal Pradesh.
